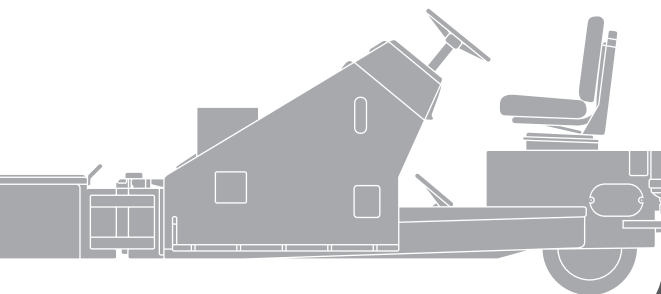




## Revenue Department joins in to support exporters

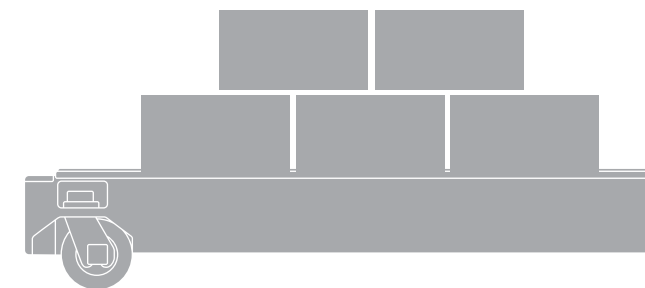

## Export Promotion Measures ○○○

### Exporting Businesses

play a critical role in Thailand's economic growth. It helps bringing in foreign currency, stimulates investment, boosts growth in manufacturing industry, improves human resources skills and knowledge, promotes improvement in technology and employs a large amount of labour force; all these factors contribute to continued growth in the Thai economy.





## Good ○○○ Exporters

Good exporters or gold card exporters, as defined by Customs Department, including businesses in industrial export zone with intra transaction which can be a company or public company that meets Revenue Department's criteria as stated in Revenue Department's notification T.159/2550 dated 9 April 2550, for example, a company which is a member or association or profit seeking private organization.

## Registered ○○○ Exporters

Registered exporters include businesses in industrial exporting zones which have intra transaction which can be registered co., partnership registered or VAT registered individuals. Individual exporters that qualify as stated in Revenue Department's notification T.159/2550 dated 9 April 2550, for example, members of association or profit seeking organizations.

## You can apply for good or registered exporters at ○○○

- General administration section at Bureau of Large Business Tax administration under supervision of Large Taxpayers Office
- General administration section at Bangkok Area Revenue Offices 1-30 for businesses located within Bangkok
- General administration section at Provincial Area Revenue Office for businesses located outside Bangkok.

## Privilege attained ○○○

Once you have been granted as good or registered exporter you will receive VAT refund much quicker than other category of exporters, especially if VAT refund is filed through [www.rd.go.th](http://www.rd.go.th)
