Subject : Revenue collection during the eleven months of the fiscal year 2019 exceeds

the target for 3.6 billion baht

Dr. Ekniti Nitithanprapas, Director-General of the Revenue Department, disclosed that the revenue collection during the eleven months of the fiscal year 2019 (October 2018 – August 2019) is a total of 1,775,101 million baht, exceeding the budget document's target (2 trillion baht) by 36,118 million baht or 2.1 percent and the previous year's collection by 85,548 million baht or 5.1 percent.

Mr. Pinsai Suraswadi, Principal Advisor on Strategic Tax Administration as spokesman of the Revenue Department, added that key tax collections are as follows:

- Corporate Income Tax: 554,121 million baht of tax collection, exceeding the budget document's target by 4,521 million baht and the previous year's collection by 4.2 percent. This result from the improved operating performance of corporations compared to the previous year.
- **Petroleum Income Tax**: 99,556 million baht of tax collection, exceeding the budget document's target by 52,986 million baht and the previous year's collection by 56.6 percent due to tax collection monitoring and increased in petroleum's price.
- Specific Business Tax: 56,539 million baht of tax collection, exceeding the budget document's target by 1,193 million baht and the previous year's collection by 2.4 percent as a result of rising immovable property transfer before the enforcement of "Second resident credit" measure in April 2019.
- Stamp Duty: 14,680 million baht of tax collection, exceeding the budget document's target by 352 million baht and the previous year's collection by 5.5 percent due to increased contract and instrument transactions following public and private investment projects.
- Value Added Tax (VAT): 736,416 million baht of tax collection, fall short of the budget document's target by 22,188 million baht but still higher than the previous year's collection by 1.2 percent due to the trade war between United States of America and China. This directly affects VAT collection imposed on import activities.
- Dr. Ekniti Nitithanprapas, Director-General of the Revenue Department, concluded that although the Revenue Department's tax collection might be affected by international economic factors for instance, US-China Trade War, the Revenue Department will increase its efficiency in tax collection and introduce the application of the digital technology to administer tax collection.

To recapitulate, the Revenue Department is confident that it will meet the budget document's target of 2 trillion baht in tax collection. This contributes to the preservation of Thailand's fiscal stability.
